**Entry Fee:** \$130.00 per gymnast – **All entries are to be done through USAG Meet Reservations and paid for on MeetMaker.com**

Refunds will be issued for scratches that are accompanied by a doctor's excuse and are received 7 days or more prior to competition.

**Qualification Scores:** 35.00 AA at State Meet.....Petition score 36.00 AA....Declared Specialist Event score = 9.3 at State Meet for L 10 and 9.5 for L 9's at their State Meet. NO L 9 event specialist petitions will be accepted.

Individual event specialists are allowed to petition to Level 10 Regionals with the score of 9.55 or higher from a previous meet during the same season.

Injury petitions are allowed for Level 9 & 10 Regionals. All petition information must be sent to the RTCC with a copy to the RDPC and the RACC. Online entries must be marked petition. **Entry Deadline:** The Monday following State Championships (March 22<sup>nd</sup> – for MS & GA and March 29<sup>th</sup> – for ALL other States)

If a gymnast's Regional Meet entry is NOT registered online by the deadline, in order to enter the gymnast(s) in the Regional Meet, the following penalty will be assessed:

- A \$50 late fee per gymnast (in addition to the regular entry fee) must be paid to the Region 8 Committee. This fee is paid on Meetmaker.
- Fines must be received prior to competition day.

**Format:** Modified Capital Cup (Judges Switch)

**Equipment:** AAI supplied by Lightning City Gymnastics

\*There will be a max of 4 coaches credentials per club, allowed at Level 9 & 10 Regionals. Contact the RACC if more are needed. There will be a fee of \$100 per additional coach.

**Admissions:** 1 Session\* = Adults (19+) \$15.00, Student (6-18) \$10.00, Seniors (65+) \$10.00  
Children 5 and under are FREE

\*There will be a **200** person MAX in the spectator seating area in the arena. This will be monitored. Because of these strict requirements, we are going to ask that only FOUR spectators per athlete (the 4 MAX includes siblings) come to the event. We will also have to clear the arena after each session for cleaning and to control the seating arrangements. With that said, our admission prices are for one session and one session only! Also, we ask that athletes only attend the session that they compete in, there are simply not enough seats in the stands for athletes to watch their teammates.

**There will be no discount or complimentary admission for USAG registered athletes not competing in these Championships.**
